Why am I in Alderley Unit?



You are in Alderley Unit under section 47 of the Mental Health Act 1983.

You have been moved from prison to the Alderley Unit.



This is because 2 doctors have told the ministry of justice that you have a mental disorder and that you need to be in the Alderley

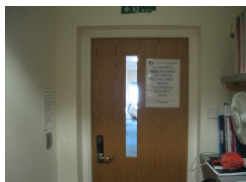
How long will I be in Alderley Unit?



The section 47 will be reviewed after 6 months, then after another 6 months and then every year.

This is so you can get the treatment you need.

The person in charge of your care will talk to you every time your section is reviewed.



You must not leave the Alderley Unit unless the person in charge of your care says you can leave.

What happens if my sentence ends while I am in the Alderley Unit?

If your sentence ends and you still need treatment then you will have to stay at the Alderley Unit.

What treatment will I be given?



The staff looking after you will talk to you about any treatment they think you need.

After 3 months you can say if you do not want medicine or drugs.

A doctor from another hospital will visit you and talk to you and the staff at the Alderley Unit.



The doctor from another hospital will decide what medicine and drugs you can be given.

What if I want to leave Alderley Unit?

In the first 6 months you can ask the tribunal to say you can leave Alderley Unit.

After 6 months you and your nearest relative can ask the tribunal to say that you can leave Alderley Unit.

What is the Tribunal?



The tribunal is an independent group of people.
They decide if you should be allowed to leave Alderley Unit.
They will have a meeting with you and staff from Alderley Unit.

Letting your nearest relative know



Your nearest relative will be informed that you are in Alderley Unit on a section 47.

We have been told your nearest relative is

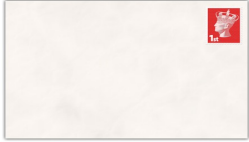
If you do not want this person to receive a copy of this leaflet, please tell your nurse or another member of staff.

Changing your nearest relative



You may not want this person to be your nearest relative.
You can ask the court to change your nearest relative.
You can ask staff to help you

Your letters



You will get all letters sent to you.

You can send letters to other people unless they do not want a letter from you.

How do I complain?



We have a leaflet that tells you how to make a complaint.

Staff will give you a copy of the leaflet.

Further help and information

If there is anything you do not understand about your care or treatment a member of staff will try to help you.

You can also get help from a **mental health advocate**.

An advocate is someone who can support you and speak up for you at any time.

If you would like an advocate, speak to the staff.

There is an advocate at Alderley Unit who can come and talk to you.
