## **Bowmere Hospital Inspection Report**

The Care Quality Commission (CQC) visited CWP's Bowmere hospital, Chester, on 17th January 2014. This was an unannounced responsive inspection to check that essential standards of quality and safety were being met.

## **Springview Hospital Inspection Report**

**Date of Inspection:** 14 November 2013 **Date of Publication:** January 2014

The Care Quality Commission (CQC) visited CWP's Springview hospital at Clatterbridge, Wirral, on 14th November 2013. This was an unannounced routine inspection to check that essential standards of quality and safety were being met. Two wards were inspected: Brakendale ward (adult/older people's mental health) and Oaktrees (adult eating disorder ward). The inspection report indicates areas of compliance and two areas of noncompliance. The two areas of non-compliance were considered to have a minor impact on people who use the service.

Tim Welch, deputy chief executive, comments: "We welcome the findings of this inspection and have immediately acted upon them to improve the patient experience in the areas identified. Our priority is to provide the best possible care for patients and we view visits from the CQC as an opportunity to take a step back and really challenge ourselves to be the best at what we do."
